

OFFICIAL RULES
CHEQUE CASHING PROMOTION 2022
SPEEDY CASH CANADA

This promotion is open to legal residents of Canada who are the age of majority at the time of entry. The promotion is sponsored by SPEEDY CA\$H with its head office located at 202-1967 Trans Canada Highway East, Kamloops, British Columbia, V2C 4A4. The promotion is subject to all federal, provincial and local laws and regulations and is void where prohibited. No substitutions or exceptions will be made. This promotion is not an incentive to borrow with SPEEDY CA\$H.
